



Environment and Security (ENVSEC)

Supporting ENVSEC initiative at both conceptual, management and technical levels

Background

During the second half of 2002, a new initiative of UNEP's Regional Office for Europe (ROE), supported by GRID-Europe and other UNEP units, was begun, under the theme of "Environment and Security". The general purpose of this project, carried out in collaboration with UNDP and the Organisation for Security and Cooperation in Europe (OSCE) is to identify linkages between major environmental concerns within European sub-regions and countries, and existing or potential security problems that impact on people and states. The North Atlantic Treaty Organisation (NATO) became an associate member of the Initiative in 2004 through its Public Diplomacy Division. From 2006 onwards the Initiative has been strengthened with two new members: the United Nations Economic Commission for Europe (UNECE); and the Regional Environment Center for Central and Eastern Europe (REC).

Objectives


This project seeks to facilitate a process whereby key public decision-makers in South Eastern and Eastern Europe, Central Asia and the Caucasus are motivated and given the opportunity to advance and protect peace and the environment at the same time. Environmental concerns relating to shared natural resources range from threats to biodiversity and human livelihoods to land degradation and international waters. Other issues are obsolete or polluting industrial and waste sites, including nuclear ones, and their impacts either locally within countries or especially as trans-boundary phenomena.



GRID-Europe Support

GRID-Europe is supporting this Initiative at the conceptual, management and technical levels. This includes taking part in the project's steering committee meetings and workshops, and through preparation of digital cartographic products, which demonstrate existing environmental concerns and issues, as well as relevant policy measures (conventions, treaties, etc.).
